Background: The event is organised during the Slovenian EU Council presidency and under the framework of the Civil Society Convention on the Future of Europe to discuss the current and future Europe's digital transformation policies and actions.

The Convention is the only platform of the organized civil society across Europe, which aims to provide structured input on behalf of more than 90 civil society networks to the Conference on the Future of Europe. Its members are committed to ensure an ambitious and forward-looking agenda for the Conference and a meaningful civil society input that will be taken into account in the follow-up of the Conference with concrete policy impact.

One of the clusters of the Civil Society Convention is the **Digital Transformation Cluster**. It works to collect proposals from civil society organisations that will feed into the EU's policies of "A Europe fit for the digital age". The ambition is to strengthen the EU's digital sovereignty and set standards on data, technology, and infrastructure - with a clear focus on education, ethics, fundamental rights, and European values.

The Convention's Digital Transformation Cluster policy proposals will be based on crowdsourcing the ideas of civil society organisations across Europe on *Digital Democracy, Digital Economy, Digital Education, Digital Safeguards and Digital Rights.*
